The Human Use Regulations 2012 No. 1916 Schedule 20 Part 1 (http://www.legislation.gov.uk/uksi/1977/2130/made)	Prohibits the sale or supply (including general retail or following a one-to-one consultation with a practitioner) of herbal medicines in the UK, if it contains one or more of the listed plants, except where sold in premises which are registered pharmacies and by or under the supervision of a pharmacist.
The Human Use Regulations 2012 No. 1916 Schedule 20 Part 2 (http://www.legislation.gov.uk/uksi/1977/2130/made)	Plants listed in Part 2 can only be sold in herbal medicines following a one-to-one consultation with a practitioner, at the dosages in column 2 or percentage of the substance in the product not exceeding that specified in column 3. If the dosage (or percentage of the substance in the product) specified is exceeded, the herbal medicines containing these plants can only be supplied in premises which are registered pharmacies and by or under the supervision of a pharmacist.
